

## Chapmanslade Parish Council

The planned meetings for Chapmanslade Parish Council for April and May have been cancelled due to the lockdown presently in place regarding the Covid-19 pandemic. The Annual Parrish Meeting and the Annual Parish Council meeting are no longer required to take place for this period of time.

The business of the council will however continue to take place and particularly where items have a required deadline, decisions are required and where items of concern are raised. E.g. Planning Applications.

Whilst councillors can discuss items and come to an agreed decision through remote working, the council will ensure that where the public would normally have been given the opportunity to make comments or raise items, the council will use the website to post information and /or documents being discussed by councilors so that members of the community have the opportunity to also put forward their comments. The consultation deadlines for responses to Wiltshire Council are listed below and the Parish Council would encourage you as normal to make your responses directly to Wiltshire Planning. In order for the council to be able to take your comments into account within their discussions, a deadline date of 1 week before the consultation is required to ensure your comments can be given due consideration.

Checking the website for new applications that might be of interest to you is also advisable and a list of applications is also usually listed in the weekly edition of the Warminster Journal.
