**Notice of adoption of the Wiltshire Housing Site Allocations Plan**  
**(Development Plan Document)**  
**Adoption Statement**

Notice is hereby given in accordance with Regulations 17, 26 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended), that the Wiltshire Housing Site Allocations Plan ('the Plan') was formally adopted by Wiltshire Council on 25 February 2020.

The Plan allocates sites for housing development to support the Wiltshire Core Strategy and provides an appropriate basis for the planning of the County for the period up to 2026. In addition, the Plan provides updated settlement boundaries ('Limits of Development') for Wiltshire's Principal Settlements of Salisbury and Trowbridge; Market Towns; Local Service Centres; and Large Villages.

The Plan was the subject of an independent examination conducted by an Inspector appointed by the Secretary of State. The Inspector's Report was published in 27 January 2020 and the recommended main modifications have been included in the adopted plan along with additional modifications which do not materially affect the policies, pursuant to section 23 of the Planning and Compulsory Purchase Act 2004 (as amended) Now adopted, the Plan forms part of the Development Plan for Wiltshire.

In accordance with regulation 26 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended) the Plan and associated documents (including this Adoption Statement, Inspector's Report, Sustainability Appraisal (SA) Report and SA Adoption Statement, and Habitats Regulations Assessment (HRA) are available to view on the Wiltshire Council website at: <http://www.wiltshire.gov.uk/planning-whsap>

From Friday 6 March 2020 copies of the Plan, and associated documents will be available for viewing at the following locations during normal opening hours:

- the council's main offices at County Hall (Trowbridge, BA14 8JN), Monkton Park (Chippenham, SN15 1ER), Bourne Hill (Salisbury, SP1 3UZ; and
- in all Wiltshire Council libraries.

Copies of any of the documents listed above and this Adoption Statement may be obtained on request and upon payment of a reasonable charge for such copies.

Any person aggrieved by the Plan may make an application to the High Court under Section 113(3) of the Planning and Compulsory Purchase Act 2004 (as amended) on the grounds that the document is not within the appropriate powers of the local planning authority and/or that a procedural requirement has not been complied with. Any application must be made no later than six weeks beginning the day after the date of adoption (i.e. 6 weeks beginning on 26 February 2020). A copy of this Adoption Statement has been sent to the Secretary of State for Housing Communities and Local Government.
